SUBJECT: ISSUANCE OF AMENDMENT (TAC NO. 77556)

The Commission has issued the enclosed Amendment No. 46 to Facility Operating License No. PR-21 for Millstone Nuclear Power Station, Unit No. 1, in response to jour application dated September 11, 1990. The amendment will modify the Millstone Unit 1 Technical Specifications (TS) by changing the containment spray interlock trip level setting in TS Table 3.2.2 from between 4.5 and 5.5 psig to between 9.0 and 10.0 psig.

Northeast Nuclear Energy Company requested that the proposed amendment be reviewed on an emergency basis and that a Temporary Waiver of Compliance be granted to allow Millstone Unit 1 to return to power while the proposed amendment was being processed by the NRC staff. Verbally, on September 11, 1990, the NRC staff granted a Temporary Waiver of Compliance to allow the restart of Millstone Unit 1 with the condition that the proposed TS change and associated procedures be implemented. The Temporary Waiver of Compliance was documented in a letter dated September 12, 1990.

A copy of the related Safety Evaluation is also enclosed. The notice of issuance will be included in the Commission's biweekly Federal Register notice.
