SUBJECT: PHYSICAL SECURITY INSPECTION AT ZION GENERATING STATION

This refers to the inspection conducted by Mr. J. L. Belanger of this office on February 14-18 and 22-24, 1994. The inspection included a review of activities authorized for your Zion Nuclear Power Plant facility. At the conclusion of the inspection, the findings were discussed with Mr. T. Broccolo and other members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel and observation of activities in progress.

Based on the results of this inspection, certain of your activities involving the control of security badges/key cards appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). The violation is of concern because it represented one of many recent examples of individuals failing to exercise control of their keycards/security badges. Safety significance was low because no unauthorized use of the badge occurred.

Although Section 2.201 provides for a written statement of explanation to this office within 20 days of your receipt of this Notice, we noted that this violation had been corrected and those actions were reviewed during this inspection. Therefore, no response with respect to this matter is required.

The material enclosed (Enclosures 1 and 2) herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, this material will not be placed in the Public Document Room. The non-safeguards information, contained in Enclosure 3, will be placed in the Public Document Room.
