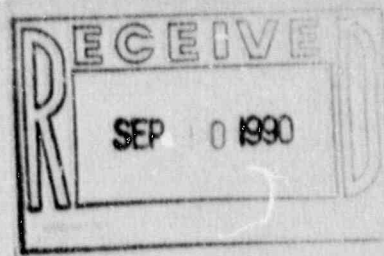
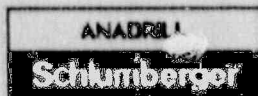



- All storage containers will have signs as per 10 CFR 20.203 (f)(2), (see attachment 3).
- Such signs will be removable or coverable as per 10 CFR 20.203 (f)(4), (see attachment 3).
- This letter and attachments 1, 2 and 3 will be posted as per 10 CFR 19.11 (a)(4), (b), (c), (d), (see attachment 4).
- The actions must be complete by 4-Oct-90.
- Posting in Scott, Louisiana and Sugar Land, Texas will commence upon receipt of this notice and cease on 4-Oct-90 or when complete compliance is achieved, (10 CFR 19.11 (e)).

This is a more conservative interpretation of the regulations and as such the preferred standard of operation for Anadrill. Please attend to this matter as soon as possible and indicate in writing when the actions are accomplished.
