SUBJECT: NRC INSPECTION REPORT 50-313/94-01; 50-368/94-01

This refers to the inspection conducted by Mr. S. L. McCrory and other members of an NRC team on March 1-11, 1994. The inspection included an assessment of the qualifications of 11 individuals who had applied for licenses to operate your Arkansas Nuclear One, Unit 1, facility and one individual who failed a portion of a previously NRC administered requalification examination. At the conclusion of the inspection, findings of generic significance were discussed with those members of your staff identified in the enclosed report. Appropriate licenses have been issued to all 11 applicants, who successfully completed all portions of their examinations. The currently licensed individual successfully completed the required retake portions of the requalification examination and will be eligible for license renewal at the expiration of the current license.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of evaluation of license applicants and the requalification examinee by the use of written examinations, dynamic simulations, selected job related tasks, and oral questioning in accordance with NUREG-1021, "Operator Licensing Examiner Standards," Revision 7. The results of this inspection are documented on page 1 in the enclosed report.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
