This is in response to your August 22, 1990 letter to the Director, Office of Nuclear Material Safety and Safeguards of the NRC, requesting information on two items relating to 10 CFR Part 21.

Requested Item No. 1: Information Notice No. 88-XX (Draft) - Potential For Loss of Post-LOCA Recirculation Capability Due to Insulation Debris Blockage.

NRC Information Notice 88-28, with the same title was issued May 19, 1988. A copy is enclosed.
