The purpose of this modification is to (1) provide incremental funding in the amount of \$116,577.00 which increases the obligated amount from \$373,000.00 to \$489,577.00, and (2) increase the level of effort for Dr. Alexei Tumarkin from 33% to 66% for six months, effective from the date of this action, as referenced in the University of California - Santa Barbara's letter dated 10/20/93 (copy attached). The level of effort change will not affect the contract ceiling. Accordingly, the following change is hereby made:

 Under Section B.3.c, "CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE," is hereby revised to read as follows:

"c. The amount obligated by the Government with respect to this contract is \$489,577.00."

All other terms and conditions under this contract including the ceiling amount of \$439,577.00 remain unchanged.
