Subject: Enforcement Meeting

On August 24, 1982, representatives of Carolina Power and Light Company met with NRC Region II and other NRC personnel in Atlanta, Georgia to discuss the status of action items contained in Confirmation of Action letters dated July 2 and July 20, 1982. The attendance list is attached as Appendix A to this Summary. The meeting was held at the request of NRC Region II.


The NRC Regional Administrator opened the meeting with a summary of the missed surveillance event chronology followed by a reiteration of NRC concerns in this area.

Following these opening remarks, CP&L representatives presented the following information:

- Conclusions of the External Review Panel, drawn from a presentation to this panel (composed of three non-CP&L industry representatives) by CP&L on August 13, 1982;
- Update on Pre-Start Items, including the current status of action items contained in the Confirmation of Action letters referenced above;
- Review of Post Startup Improvement Program, detailing program purpose, scope, structure, implementation methodology, specific objectives and associated action items.

At the conclusion of this presentation, CP&L answered questions regarding the above items and committed to formally submitting the long term program details to NRC Region II in November 1982.

NRC concerns and comments were summarized and the meeting was adjourned.
