SUBJECT: NRC INSPECTION REPORT 030-33158/93-01

This refers to the routine, unannounced inspection conducted by Mr. Gilbert L. Guerra, Jr., of this office on December 6, 1993. The inspection included a review of activities authorized by Byproduct Materials License 35-12400-03. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspector verified that the licensee possessed only a Monsanto 3-curie americium-241/beryllium source (model MRC-N-SS-W-Ambe, S/N 607) as indicated in its storage only license. The source was stored in a standpipe cemented into the ground which had a lockable cap. The last leak test performed on the source was on May 14, 1992, with negative results.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
