On February 9, 1994, Anthony Kirkwood of this office conducted a routine safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records.

Based on the results of this inspection, it appears that your activities were not conducted in full compliance with NRC requirements.
