VOGTLE ELECTRIC GENERATING PLANT IDENTIFICATION OF INSERVICE INSPECTION PLAN DIFFERENCES

Georgia Power Company (GFC), in response to its June 7, 1990 verbal commitment to NRC staff personnel, submits the enclosed information which identifies the differences between the Vogtle Electric Generating Plant (MEGP), Units 1 and 2 Inservice Inspection (ISI) Plans. The subject information is being provided to assist the NRC and its contractor, EG&G-Idaho, in the review and approval process associated with the ISI Programs at VEGP.

The ISI Plan documents of record used in developing the enclosed information are Revision 3 of document no. ISI-P-005 for VEGP-1 and Revision 2 of document no. ISI-P-013 for VEGP-2. Since the ISI Plans are "living" documents, there are differences between Revision 3 and Revision 0 of the VEGP-1 ISI Plan, which was originally submitted to the NRC by GPC letter SL-3321 dated October 21, 1987. Although the ISI Plan documents are not normally submitted to the NRC, Revision 0 of the VEGP-1 ISI Plan (ISI-P-005) was submitted to the NRC in response to a verbal request from NRC staff personnel in 1987. A similar request was not made at the time for a copy of the VEGP-2 ISI Plan (ISI-P-013). While there are differences between the various revisions of the ISI Plan for the respective VEGP unit, the criteria on which the Plans are based remain unchanged.

During our review, nine relief requests were identified which require evaluation and/or revision. Changes to the ISI Plan and/or Program documents incorporating any necessary changes will be made during a future revision of the affected document(s).

Three copies of the enclosed information are provided for your review. Two copies of the subject information are being provided to both the Regional Administrator for NRC Region II and EG&G-Idaho.
