Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Continued strong performance in the radiation protection program was noted. Health Physics control of work activities was generally very good, and ALARA goals were generally being met. A strong program for dosimetry records and for instrument calibration was also observed.

No violations of NRC requirements or safety concerns were identified. No response to this letter is required.

Your cooperation with us in this matter is appreciated.


