SUBJECT: NOTICE OF VIOLATION (NRC INSPECTION REPORT NO. 45-23645-01NA/94-02)

This refers to the inspection conducted by Mr. James L. Montgomery of the NRC's Region V office on March 4, 1994. The inspection included a review of activities authorized for the Navy Drug Screen Laboratory San Diego under Naval Radioactive Materials Permit (NRMP) No. 04-68853-61NP. At the conclusion of the inspection, the findings were discussed with CAPT. J. Christopher, MC, USN, Commanding Officer and members of his staff. The findings were also discussed in a March 25, 1994 telephone conversation between Mr. Jerry Ennis, NRC Region II, and CAPT J. Malinoski of your staff.

The inspection was an examination of activities conducted under your license with respect to radiation safety and compliance with NRC regulations and the conditions of your license. It included selective examinations of procedures and representative records, interviews with personnel, and direct observations by the inspector.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). In addition, the inspector identified activities that violated NRC requirements that will not be subject to enforcement action because the licensee's efforts in correcting the violation meet the criteria specified in Section VII.B of the Enforcement Policy. The non-cited violation concerned the marking of containers in which radioactive materials were stored with labels which did not conform to the requirements of 10 CFR 20.1904. This item was also discussed with CAPT. Christopher at the conclusion of the inspection.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future

inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.
