
This letter transmits the findings of the special safety inspection conducted by Mr. J. G. Caruso of this office from March 7 through March 11, 1994, at the Oyster Creek Nuclear Power Plant, Forked River, New Jersey. At the conclusion of the inspection, Mr. Caruso held discussions of his findings with members of your staff.

The primary objective was to determine whether the surveillance of safety-related systems and components was conducted in accordance with approved plant procedures and technical specifications. The inspection focused on areas related to safe operation of the plant and to the surveillance program. Overall, the surveillance test program was implemented in accordance with approved plant procedures and applicable technical specifications.
