

AMENDMENT TO INDEMNITY AGREEMENT NO. B-50
AMENDMENT NO. 11

Effective February 18, 1994, Indemnity Agreement No. B-50, between Public Service Company of Colorado, and the Atomic Energy Commission, dated April 21, 1971, as amended, is hereby further amended as follows:

Item 2a of the Attachment to the indemnity agreement is deleted in its entirety and the following substituted therefor:

12 midnight, December 20, 1973, inclusive)
- \$95,000,000 (From 12:01 a.m., December 21, 1973, to
12 midnight, February 28, 1974, inclusive)
- \$110,000,000 (From 12:01 a.m., March 1, 1974, to
12 midnight, March 20, 1975, inclusive)
- \$125,000,000 (From 12:01 a.m., March 21, 1975, to
12 midnight, April 30, 1977, inclusive)
- \$140,000,000* (From 12:01 a.m., May 1, 1977, to
12 midnight, April 30, 1979, inclusive)
- \$160,000,000* (From 12:01 a.m., May 1, 1979, to
12 midnight, June 30, 1989, inclusive)
- \$200,000,000* (From 12:01 a.m., July 1, 1989, to
12 midnight, February 17, 1994,
inclusive)

*and, as of August 1, 1977, the amount available as secondary financial protection

\$100,000,000 (From 12:01 a.m., February 18, 1994)
