This confirms your telephone conversation with Beverly Anker, Contract Administrator, on July 31, 1990, regarding the subject modification. Your offer of consideration for extending the period of performance of the subject contract is hereby accepted.

Therefore, the period of performance of Contract No. NRC-04-89-090 is extended through October 31, 1990. The contract ceiling and amount obligated are decreased by \$200.00, from \$105,180.00 to \$104,980.00, respectively.

Accordingly, the following changes are hereby made:

1. Section B.2 CONSIDERATION AND OBLIGATION--FIRM FIXED PRICE, is revised to read: "The firm fixed price of this contract is \$104,980.00."
2. Section F.5 DURATION OF THE CONTRACT PERIOD is revised to read: "This contract shall commence on the date of award (9/29/89) and expire on October 31, 1990."
