

Dear Sir:

The Authority is enclosing two reports relating to the FitzPatrick primary containment testing program. Attachment I is the Reactor Containment Building Integrated Leakage Rate Test Report for the June, 1990 PCILRT test. This report is submitted in accordance with the requirements of 10 CFR 50 Appendix J, §V.B.1. Included in this report is the local leakage rate test summary analysis for the "as-found" condition of the containment prior to the PCILRT test. Analysis of the test results indicates that the FitzPatrick containment exhibited satisfactory leak tightness in both the "as-found" and "as-left" conditions.

Attachment II (Containment Isolation Valve Replacement Program Report) is an evaluation of the effectiveness of the Authority's containment isolation valve improvement corrective action plan. This evaluation is submitted as discussed in Reference (1), Attachment II. The corrective action plan has achieved its stated purpose of reducing the "as-found" containment leakage rate to an acceptable value and improving the effectiveness of containment isolation valve repairs. 17 (Just No 227
