- Increases or decreases that are proposed in user fees or revenues to support program objectives. ✓
- Any necessary or contemplated legislative initiatives to implement any part of the agency's FY95 budget request or program objectives. ✓
- Please indicate if there are any rescissions, deferrals, or supplements proposed for FY95. ✓


