In accordance with your application dated December 16, 1993, and supplement dated February 11, 1994, and pursuant to Part 70 to Title 10 of the Code of Federal Regulations, Materials License SNM-1067 is hereby amended to change the enrichment range of the residue containing enriched uranium for the Windsor site to greater than 5 weight percent U-235. Accordingly, Condition S-1 of the Safety Conditions is revised to include the dates of December 16, 1993, and February 11, 1994, and Condition No. 6.F, is amended to read as follows:

6.F. Uranium enriched to greater than 5.0 weight percent U-235

All other conditions of your license shall remain the same.
