Gentlemen:

This refers to the team inspection conducted by Mr. I. Barnes and other members of the NRC staff during the period August 20-24, 1990, of activities authorized by NRC Operating License NPF-87 and Construction Permit CPPR-127 for the Comanche Peak Steam Electric Station, Units 1 and 2, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

The area examined during the inspection consisted of the plans and processes for completion of Unit 2 onsite design activities. Within this area, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. The inspection findings are documented in the enclosed inspection report.

Five inspector followup items were identified during this inspection. These items will be included in the scope of a future inspection that will be performed to allow full assessment of the onsite design program and its implementation. With respect to the inspector followup item discussed in paragraph 2.4 of the inspection report, it is our understanding that formal qualification requirements have been established for personnel performing Unit 2 engineering walkdowns. Please notify us if your understanding differs on this matter.

Within the scope of the inspection, no violations or deviations were identified.

Should you have any questions concerning this inspection, we will be pleased to discuss them with you.
