Additional Response to Notice of Violation
Inspection Reports No. 50-282/90012(DRP) and 50-306/90012(DRP)

In response to discussions with your staff, the following information is offered to clarify and amplify our response, dated September 24, 1990, to Inspection Reports No. 282/90012 and 306/90012.

The second paragraph of our response to violation #1 was not intended to take issue with the violation. The purpose of our second paragraph was to identify that prompt operator action was taken upon discovery of the inoperability.

In addition to the corrective actions identified in our response to violation #2, well-defined accountability points for the surveillance program administration will be established. Scheduling mechanisms will be implemented to include provisions for recording completion dates and determining allowable test dates. A master surveillance schedule data base will provide early notification of upcoming surveillance activities and prompt feedback of surveillance test completion. The master surveillance schedule data base will facilitate management overview of the program and provide assurance that all tests will be completed in accordance with the requirements of the Technical Specifications. These actions will be completed by January 31, 1991.
