SUBJECT: NRC INSPECTION REPORT 030-33325/94-01

This refers to the routine, announced inspection conducted by Mr. Mark R. Shaffer of this office on April 7, 1994. The inspection included a review of activities authorized by Byproduct Materials License 35-27479-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress at the licensee's temporary jobsite near McLoud, Oklahoma.

During this initial inspection, the inspector discussed with your staff the requirements with which you must comply, including the NRC and Department of Transportation regulations, and the commitments in your license application. The NRC enforcement policy was also discussed at this time.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspection disclosed that the licensee possessed one portable gauging device used for measurement of properties of materials at temporary jobsites throughout the state of Oklahoma. The inspector noted that the licensee's Radiation Safety Officer was knowledgeable of NRC requirements and had provided sufficient oversight of licensed activities. Records of byproduct material use were well organized and adequate for the size and scope of the program.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
