Subject: NRC INSPECTION OF SAN ONOFRE NUCLEAR GENERATING STATION, UNITS 2

AND 3 REPORT Nos. 50-361/94-07 AND 50-362/94-07

This refers to the special inspection conducted by Messrs. James H. Reese and F. Randall Huey of this office on March 7-10, 1994, of the activities authorized by NRC License Nos. NPF-10, and NPF-15, and to the findings discussed with Mr. R. Krieger and other members of your staff identified in the enclosed report.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

The purpose of this inspection was to evaluate your investigation into several personnel contaminations which occurred during Unit 2 pressurizer modification work on June 13, 1993. Although no violations or deviations were identified during the inspection, we concluded that your investigation into this event was too narrowly focused, in that it addressed only construction department problems, and failed to adequately evaluate or correct several health physics problems which were also identified during your investigation. During the inspection exit meeting, you agreed with this conclusion, and further noted a generic concern when investigations involved more than one department. You indicated that you were in the process of implementing an "Inter-Departmental Investigation Report" to ensure thorough evaluation and correction of all problems during future investigations. We encourage your prompt completion of this effort.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the Public Document Room.
