SUBJECT: NRC INSPECTION REPORT NO. 30-12031/94-01

This refers to the inspection conducted by Messrs. David D. Skov and John M. Jacobson of this office on February 11 and March 2, 1994. The inspection included a review of certain activities authorized for your facility in Honolulu, Hawaii. Subsequent discussions relative to the inspection were also held with Dr. Trent T. Phan and with another member of the Pacific Radiopharmacy staff on February 16-17, 1994. The inspection findings were discussed with Dr. Phan on March 2, 1994, and at the conclusion of the inspection on March 7, 1994.

Areas examined during this inspection are described in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations of activities in progress. The purpose of the inspection was to determine whether certain transportation activities and generator elution and radiopharmaceutical labeling procedures authorized by the license were conducted safely and in accordance with NRC requirements.

Based on the results of this inspection, three apparent violations were identified. However, these apparent violations are still under review and no Notice of Violation is presently being issued for these inspection findings. You will be advised when our review of this matter is completed. No response regarding these apparent violations is required at this time.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
