The University of Missouri Research Reactor (MURR) has applied for a unique purpose exemption pursuant to 10CFR50.64(c)(1) in a letter dated September 26, 1986. This application, plus additional supporting information, is currently under review by the Nuclear Regulatory Commission.

Since this review process is ongoing, the MURR is complying with 10CFR 50.64(c)(2)(ii) by submitting a copy of the Department of Energy letter to MURR, dated March 31, 1994, notifying the licensee that Federal Funds for conversion of our reactor will not be available during Fiscal Year 1994.

This submittal and attachment constitutes MURR's response for Fiscal Year 1994. The MURR will respond again prior to March 27, 1995, as per 10CFR50.64(c)(2), unless a determination is made by the Nuclear Regulatory Commission that our facility should be granted a unique purpose exemption.
