NOTICE OF NONCONFORMANCE

This refers to the U.S. Nuclear Regulatory Commission inspection performed by Messrs. D. Reid and T. Matula of this office on February 7, 1994.

The inspection consisted of an examination of procedures and representative records, and interviews with personnel at your Signal Hill, California, facility. The preliminary findings were discussed with you and your staff the conclusion of the inspection.

It was found that the implementation of your Quality Assurance Program was satisfactory in general; however, certain NRC requirements were not met. The specific findings and references to pertinent requirements are identified in the enclosed Inspection Report and Notice of Nonconformance.

Please provide us, within 30 days from the date of this letter, a written statement in accordance with the instructions specified in the enclosed Notice of Nonconformance (Notice). We will consider extending the response time if you can show good cause for us to do so. Your letter dated February 22, 1994, provided a response to our preliminary findings that were discussed at the exit meeting. Your response to the enclosed Notice may reference the applicable portions of your letter.

The responses directed by this letter and the enclosed Notice are not subject to the clearance procedures of the Office of Management and Budget, as required by the Paperwork Reduction Act of 1980, in Pub. L. No. 96-511. In accordance with 10 CFR § 2.790 of NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
