Subject: NOTICE OF VIOLATION

This refers to the telephone discussions between a member of your staff at your Middlebury, Vermont facility and John Miller of this office on October 3, 1990. The subject of the discussion was the expiration of the above named license without the submission of a renewal application and the continuation of licensed activities.

From this discussion, it is our understanding that you still possess the fixed gauges containing licensed radioactive material. Your letter dated December 22, 1988, indicated that an application would be sent to the NRC transferring the responsibility from your Corporate Office to the facility itself. As of this time, no application has been received.

This Notice of Violation is being issued because of your possession of licensed material without an active license (10 CFR 30.3). Section 30.3 states:

"Except for persons exempt as provided in this part and Part 150 of this chapter, no person shall manufacture, use, import, or export byproduct material, except as authorized in a specific or general license issued pursuant to the regulations of this chapter."

You must keep formerly licensed material in secure storage without use until a valid license is issued by the proper regulatory agency or you make arrangements to transfer the formerly licensed material to a licensed recipient.


In response, you need to submit a completed application for a new license to the Region I Office at 475 Allendale Road, King of Prussia, Pennsylvania 19406.
