Based on the limited information provided, we also do not believe the performance based approach is consistent with the requirements of Appendix R and that either a plant specific exemption or change to the rule would be necessary to implement your proposal.

The staff is currently awaiting a petition for rulemaking from the Nuclear Energy Institute (NEI) and has met with NEI representatives to discuss their approach to a performance based fire protection rule. You should consider coordinating your proposal with the NEI petition for rulemaking activities.
