Dear Mr. Igoe:

This is in response to your letter dated August 12, 1982, in which you requested, pursuant to the Freedom of Information Act, a copy of all inspection and enforcement records of the NRC involving the accidents of Fred Lawson, on July 20, 1978, and Harry Dillon, on August 4, 1978 at the Nuclear Power Plant of Union Electric Company in Callaway County, Missouri and all records pertaining thereto. You also requested a copy of the Union Electric construction permit, including the NRC safety guidelines incorporated, and any other NRC safety materials or manuals.

In response to your request we have located two documents that are subject to your request, and a copy of each is enclosed. One is a one-page copy of the Daily Report of Region III for August 7, 1978. The OSHA report referenced in the Daily Report is not in the NRC's Region III, Glen Ellyn, Illinois, files. The second document (Reference PN-III-78-62) is dated August 4, 1978, and is a Preliminary Notification of a construction accident. (1 page) The Construction Permit and related documents you also requested are already on file for public inspection and copying in each of two of the NRC's Local Public Document Rooms (LPDR) for the Callaway nuclear power facility. One LPDR is located at the Olin Library of Washington University, Skinker and Lindell Blvds., St. Louis, Missouri, 63130, Mrs. Ranata Rothkowitz, Director for Public Services, P.O. Box 1061, (314)889-5400. The second LPDR is located at the Fulton City Library, 709 Market Street, Fulton, Missouri 65251, Mrs. Landonna Justice, Administrator (314) 642-7261. For your information, the collection of Callaway documents at each of these locations occupies approximately 60 linear feet of shelf space. For this reason it would be prudent for you to examine these records to determine which specific documents should be duplicated to serve your needs.

The documents on file in the NRC LPDRs are available for public inspection and copying during normal business hours.

To assist you in locating documents on file in the LPDRs, a copy of an index list of the file subjects is enclosed. The specific information you are seeking probably is contained in the file categories 4, 5, 13, 14, 15, 16, 21, and 22, in the LPDRs. If you have any questions when you visit the library, you may telephone the NRC's LPDR Branch toll free on (800)638-8081. Also, if you have any other questions in this matter, please feel free to contact Mr Frank W. Karas of my staff on (301) 942-2733.

With respect to that portion of your request which reads:

"In addition we would like any information regarding how you go about letting the employees of Daniel International know beforehand that you're coming to make an inspection",


we wish to state the following:

There are some activities which NRC regional inspectors are required to witness and the NRC licensee is required to notify us when those activities are scheduled to take place. Other times we may need to talk with certain people at the site and we will telephone ahead to make sure they are onsite. These situations result in the licensee knowing when NRC personnel are coming. It is NRC policy to conduct unannounced inspections unless site activities or site personnel availability dictate otherwise. The cover page of each NRC inspection report indicates if a given inspection was announced or unannounced.

If allegations state that because of prior knowledge of an NRC visit, the licensee has altered their method of doing business in order to suppress information necessary to an NRC inspection, then our regional office would consider undertaking an investigation.

This completes action on your request.
