SUBJECT: FLORIDA POWER COMPANY - CRYSTAL RIVER UNIT 3 (TAC NOS. M88674 AND M74563)

The purpose of this memorandum is to correct the licensee application date in the Nuclear Regulatory Commission's (NRC or the staff) Workload Information and Scheduling Program (WISP) which is a tool to manage staff workloads.

By letter dated August 25, 1989, Florida Power Company (the licensee) proposed changes to its technical specifications (TS) for Crystal River Unit 3 for implementing standard Babcock and Wilcox Technical Specifications (TS), NUREG-1430. The staff performed its review under Technical Assignment Control (TAC) No. M74563 and on December 20, 1993, issued Amendment No. 149 to Facility Operating License No. DPR-72 for Crystal River Unit No. 3. With the issuance of Amendment 149, TAC No. M74563 was closed.

On January 31, 1994, the staff opened a new TAC No. M88674 to perform followup activities relating to the implementation of the new TS (Amendment 149). The WISP "Application Date" column for this effort incorrectly indicates August 25, 1989 (licensee initial application date for the proposed new TS). The correct date should be the date when Amendment No. 149 was issued. The WISP will be updated accordingly.
