This modification exercises the Government's option to extend the contract for an additional twelve (12) month period from November 7, 1990 through November 6, 1991. Therefore, the contract is modified as follows:

A. Prices under Paragraph B.3.E shall be in effect for the period November 7, 1990 through November 6, 1991.

B. Subparagraphs a, and g, under Paragraph B.4. OBLIGATION AND CONSIDERATION, are revised to read as follows:

"a. It is estimated that the total cost to the Government for full performance under this contract, inclusive of the basic year, and Option Years 1, 2, 3, and 4 will be \$8,436,195.

g. The total amount presently obligated for performance of the contract is \$8,145,002."

C. Paragraph F.2, TERM OF CONTRACT, is deleted in its entirety, and the following paragraph is substituted in lieu thereof:

"F.2 TERM OF CONTRACT

The contractor shall provide services under the contract from November 7, 1986 through November 6, 1991."

All other terms and conditions of this contract remain unchanged.
