SUBJECT: RELAXATION OF SECTION VI OF THE ORDER SUSPENDING OPERATIONS AND
MODIFYING LICENSE (EFFECTIVE IMMEDIATELY), DATED MAY 2, 1990

On May 2, 1990, the NRC issued an Order to you. The last element of Section VI of the Order required that within 30 days after your receipt of the consultant's report, required by Section VI.D.1 of the Order, a plan be submitted to the Regional Administrator, NRC Region I in response to the findings and recommendations of the consultant's report, which describes how you will incorporate and implement recommendations set forth in the report, as well as a schedule for implementation of the recommendations. Based on the consultant's report being issued on October 1, 1990, submittal of your plan pursuant to the aforementioned requirement was due to the Regional Administrator, NRC Region I by November 1, 1990.

We understand from telephone conversations on October 30, 1990, between Mr. Bruce Ballard of your staff, and Mr. Richard W. Cooper of this office, that you request an extension of the time to submit the required plan. Accordingly, we will extend the date by which the submittal will be provided to no later than November 23, 1990.
