Perry, and T. Easlick, from February 23, through March 28, 1994, at the Limerick Generating Station, Limerick, Pennsylvania. The inspection focused on issues important to ensuring the public health and safety and onsisted of observations of activities, reviews of documents and interviews with plant personnel. The results are documented in the enclosed report and were discussed with Mr. L. Hopkins of your staff at the conclusion of the inspection. In general, activities were found to be conducted safely. Although a deficiency was identified with the control of housekeeping in one area, overall the control of housekeeping was found to be excellent. In particular, the closeout inspection of the Unit 1 drywell was found to be comprehensive, with very good management attention. Additionally, activities associated with the repair of the Unit 1 recirculation pump discharge valve were found to be well planned and concolled. In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room. Your cooperation is appreciated.
