SUBJECT: COMBINED INSPECTION REPORT NOS. 50-352 AND 353/94-05

This letter refers to the announced safety inspection conducted by Ms. C. D. Beardslee of this office on February 7 - 12 and February 28 - March 4, 1994, at the Limerick Generating Station, Units 1 and 2. Ms. Beardslee discussed the findings of the inspection with members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I inspection report, which is enclosed with this letter. The inspection was directed toward the inservice inspection program and related activities. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations or deviations were observed. Overall, the inservice inspection program was found to be good and the implementation of the program adequate. No major areas of concern were identified, and with the exception of one unresolved item, the Nuclear Regulatory Commission and American Society of Mechanical Engineers Code requirements were met.
