SUBJECT: INSPECTION NO. 70-371/90-204

The Nuclear Regulatory Commission (NRC) conducted an unannounced safeguards nuclear material control and accounting inspection of your facility on August 21-24, 1990. The inspection included a review of activities authorized for your Uncasville facility and consisted of selective examination of procedures and representative records, interviews with personnel, and observation of activities in progress. At the conclusion of the inspection, the findings were discussed with members of your staff. Enclosed are the Inspection Report Summary (Enclosure 1) and the Inspection Report Details (Enclosure 2).

The inspection findings indicate that certain activities appeared to violate NRC requirements. The violation, references to pertinent requirements, and details to be addressed in your response are described in the Notice of Violation (Enclosure 3). Also enclosed is a list of recommended changes to the Fundamental Nuclear Material Control Plan (Enclosure 4). We would appreciate your comments on these recommendations.

In accordance with Section 2.790(d), documentation of the findings of your control and accounting procedures for the safeguarding of special nuclear material are exempt from public disclosure; therefore, the enclosed Notice of Violation (Enclosure 3) and the recommended plan changes (Enclosure 4) will not be placed in the Public Document Room.

The responses directed by this letter and its enclosures are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, P.L. No. 96-511.
