This refers to the inspection conducted by Mr. L. Miller of this office on August 2 - 31, 1982, of activities authorized by NRC License No. DPR-13, and to the discussion of our findings held by Mr. Miller with Mr. Ray and other members of the Southern California Edison Company staff at the conclusion of the inspection.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

No items of noncompliance with NRC requirements were identified within the scope of this inspection.
