SUBJECT: REVISED APPENDIX A TO THE LICENSING REVIEW BASIS (LRB) DOCUMENT FOR THE COMBUSTION ENGINEERING, INC. (CE) SYSTEM 80+ EVOLUTIONARY LIGHT WATER REACTOR

As discussed by Mr. Edward Scherer, CE and Dr. Thomas Murley, NRC on November 2, 1990, during a visit by Mr. Scherer, we have received a request from Chairman Carr for some additional information that we must obtain as expeditiously as possible. On August 28, 1990, CE submitted some revisions to the proposed LRB that included, as Appendix A, an up-dated listing of differences between the CE System 80+ design and the Advanced Light Water Reactors (ALWR) Requirements Document.

Please, provide for each item listed in Appendix A a description in more specific detail why CE has addressed these issues for the System 80+ in a different manner from that described in the ALWR Requirements Document.
