Your letter to me of November 1, 1990 states the copy that you received of Licensee's October 30 filing did not include "Licensee's Submittal in Accordance with 'Memorandum (Memorandum of Conference Call of October 19, 1990)'" ("Licensee's Submittal"). J apologize for such error, and assure you that additional precautions will be taken with respect to future filings by Licensee. I truck that the three organizations that you represent did receive Licensee's Submittal on October 31.

Your letter also suggests that Licensee, rather than Intervenors, provide for the record the Seehars and Schwendiman articles relied upon in Intervenors' Written Presentation of October 15, 1990. As reflected at page 7 of the Memorandum (Memorandum of Conference Call) (Oct. 30, 1990), since Licensee has stated that it disagrees with Intervenors' interpretation of those two crticles, the Presiding Officer expressly requested that "the Intervenors provide him with copies of the articles or the portions thereof relied upon by the Intervenors." Intervenors appear to be in a unique position to choose whether to provide to the Presiding Officer the entire articles or any particular portions thereof that they rely upon. In any event,
