MEMORANDUM AND ORDER (Granting Motion to Dismiss Proceeding)

On October 30, following receipt of a motion to dismiss this proceeding filed by the respondent, American Radiolabeled Chemicals, Inc. (ARC), we entered an order requesting that the settlement agreement between ARC and Staff be supplied to us. We took this step because 10 CFR § 2.203 provides that any settlement or compromise of a proceeding commenced on an enforcement order such as that issued to ARC must be approved by the presiding officer.

Staff counsel responded to our Order by letter of November 1. Counsel advised that there had been no settlement of the order which Staff issued to ARC and supplied a copy of the license renewal issued to ARC on September 13 along with the Staff's cover letter

transmitting the same. That cover letter notes that the issuance of the license renewal rescinds Staff's enforcement order on which ARC had requested a hearing.

A review of the provisions of that enforcement order reveals that it suspended ARC's licenses "...pending resolution of the licensee's [existing] application for renewal...." Consequently, it appears that the Staff's order on which ARC had requested a hearing has been given the effect Staff intended. Staff counsel is correct that there is no settlement to be submitted to the Board. ARC's motion to dismiss this proceeding is granted.

It is so ORDERED.
