REPLY TO NOTICE OF VIOLATION

I agree with the violations stated in your letter of January 24, 1994.

The two violations cited occurred as a result of lack of communication between the RSO, technologist and consulting physicists.

Item 1

Because the technologist is an experienced worker at Borgess Hospital the need to detail him the conditions of our license was overlooked. I certainly did not think of this until it was pointed out to me by Mr. Mitchell when he conducted his assessment on 09-24-93.

Since becoming aware of this condition of operation I have provided the technician with a copy of our license conditions. He has studied them and he has agreed to abide by these regulations. Full compliance was achieved by March 1, 1994.

In the future all technologists will receive a copy of our license conditions and will familiarize themselves with the material and comply with the conditions stated.

Any changes from the original license plan will be submitted to the NRC and approval obtained before implementation.

Item 2

Again this occurred as a result of lack of communication. This time it was between the office director and the three parties mentioned earlier (RSO, technician and physicist).

The form submitted went directly from the office director to the technician who did not understand its full implications. He considered that he was competent in the areas he had signed and the form was returned to the NRC.

Again the full impact of the document was not understood until after Mr. Mitchell's visit and Anthony Gurczynski has regretted the assumptions he made which resulted in the violation cited.

Mr. Gurczynski has promised to read all documents carefully and to be accurate and honest in his response. The office director and physicist has been instructed to pass all material through the RSO. All items submitted to the NRC will be complete and accurate. The physicist(s) have also been asked to work more closely with us to prevent communication errors and violations. We achieved full compliance of these resolutions by March 1, 1994.

In conclusion I thank you for pointing out our errors (of ignorance). We have benefited from the criticisms and we are sure these will not occur again.
