1. Discuss each of the violations and their root causes.
2. Discuss actions taken to correct the violations and prevent their recurrence.
3. Discuss how information contained in NRC Information Notices and Newsletters was incorporated into the radiography program?
4. Did audits show that the individual who received the extremity overexposure was not making adequate surveys and was not securing the exposure device after each exposure? If so, what corrective action was taken?
5. Did other events go unreported because of lack of understanding of reporting requirements?
6. Did other events go unreported because of an incorrect calculation of personnel exposures?
