SUBJECT: NRC INSPECTION REPORT 030-32323/94-01

This refers to the routine, unannounced inspection conducted by Mr. Robert A. Brown of this office on March 15 and 17, 1994. The inspection included a review of activities authorized by Byproduct Materials License IDA-04-16. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspector reviewed with your Radiation Safety Officer (RSO) the status of your license renewal package. The RSO stated that this package is near completion and will be submitted to the NRC in the near future. Also reviewed were the authority and functions of the Radiation Safety Committee (RSC). It appears that the RSC has sufficient and appropriate authority to oversee the radiation safety program. A review of minutes of RSC meetings indicate they take a very active role in reviewing and approving requests from the research staff to use radioisotopes.

Also reviewed were the actions you had taken with respect to the violations observed during our previous inspection conducted on June 25, 1991. The inspection verified that the corrective actions for these violations had been implemented as stated in your reply dated August 21, 1991, and that these actions were effective.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
