During the period from September 22, 1990, to October 30, 1990, members of the NRC Region I staff conducted routine safety inspections at the Three Mile Island Nuclear Station. The results of the inspection findings are documented in the enclosed report. We continue to observe good overall control of TMI-1 operational activities by your staff. At the conclusion of the inspection period, Mr. F. Young, of my staff, summarized the inspection findings to Mr. Hukill for Unit 1 and Mr. Byrne for Unit 2.

One concern was identified associated with the use of handwritten step-by-step instructions to reenergize a battery charger. These instructions conflicted with an approved maintenance procedure. This is considered to be another example of a previously cited violation (50-289/90-15-02) and, therefore, ask that you address this latest concern in your response to the previous violation. Your response to the entire violation shall be submitted 30 days after the date of this letter.

Your cooperation in these matters is appreciated.
