Gentlemen:

This refers to the inspection conducted by David M. Rohrer of the Office of Inspection and Enforcement and a team of inspectors on May 18-20, 1982, of activities authorized by the Nuclear Regulatory Commission Facility Operating License No. DPR-51 and NPF-6, and to the discussion of our findings with you and members of your staff at the conclusion of the inspection.

Areas examined during the inspection and our findings are documented in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of the inspection, no violations or deviations were identified. However, the inspectors were concerned with the excessive use of simulated action during this exercise. Due to over simulation, you did not take the opportunity to adequately demonstrate your emergency response capabilities in a number of crucial areas. The actions simulated in this exercise should be fully demonstrated during the next full-scale exercise.

Also of concern are the many problem areas identified in the enclosed inspection report. We consider these "open items" which you should resolve. Therefore, your written response to these open items should be completed and submitted to this office no later than 30 days from the date of this letter.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office. by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
