This modification is being issued to provide incremental funding in the amount of \$100,000.00. The contract is therefore modified as follows:

The first sentence under B.4.b. is deleted in its entirety and the following is inserted:

"The amount presently obligated with respect to this contract is \$575,000.00."

This modification results in the amount obligated being increased by \$100,000, from \$475,000 to \$575,000. All other terms and conditions remain the same.
