SUBJECT: NRC INSPECTION REPORT 030-20307/94-01

This refers to the routine, unannounced inspection conducted by Mr. Robert A. Brown of this office on April 1, 1994. The inspection included a review of activities authorized by Byproduct Materials License 35-23145-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

It was noted by the inspector that the Radiation Safety Officer (RSO) was the sole user and owner/operator. The majority of work is performed in oil and gas wells within 50 miles of Dewey, Oklahoma, utilizing a single sealed source on a logging truck. A review of records indicated that the records management program is well organized.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
