This refers to the routine, unannounced inspection conducted by Mr. Robert A. Brown of this office on March 30, 1994. The inspection included a review of activities authorized by Byproduct Materials License 35-19775-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

During interviews with you, the inspector determined that your licensed activities consists of the use of sealed sources for open and cased hole logging operations. These operations occur approximately 10 times per month, generally in northeast Oklahoma. Your radiation safety program appears adequate for the scope of your activities and your recordkeeping system was well organized.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
