This refers to the routine, unannounced inspection conducted by Mr. Robert A. Brown of this office on March 31, 1994. The inspection included a review of activities authorized by Byproduct Materials License 35-18099-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of vities conducted under the license as they relate to radiation safety an oliance with the Commission's rules and regulations and the conditions license. The inspection consisted of selective examinations of process and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspector determined that your licensed activities consist of the use of one radiographic device containing 29 curies of cobalt-60. Your radiation safety program appeared well managed with adequate support from management. In addition, your Radiation Safety Officer was knowledgeable about NRC requirements and conditions of your license.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
