SUBJECT: SUMMARY OF MEETING WITH PUBLIC SERVICE COMPANY OF INDIANA TO  
DISCUSS STANDARD REVIEW PLAN CONFORMANCE REVIEW REQUIRED BY  
10 CFR 50.34(g)

A meeting was held at NRC Headquarters, 7920 Norfolk Avenue, Bethesda, Maryland on Friday morning, September 17, 1982. The applicant was represented by members of Public Service Company of Indiana (PSI) and Sargent & Lundy. The NRC was represented by members of the Division of Licensing. An attendance list is attached as Enclosure 1.

This meeting was held in response to an earlier suggestion made by the staff that PSI inform the staff of its progress on the review and its schedule for completion of the review.

The applicant reaffirmed its plans to tender the Marble Hill FSAR and ER in December of 1982. The staff verified that deferment of the SRP conformance review from the initial FSAR submittal will not affect the staff's acceptance of the submittal for docketing.

PSI discussed the format of the SRP conformance review as it will be included in the FSAR. Differences from the SRP criteria along with the applicable SRP section and the corresponding FSAR section will be listed in tabular format in Section 1.8 of the FSAR. In order to ensure that the FSAR will be as much a replicate of the Byron/Braidwood FSAR as possible, PSI will include the discussion of each difference in Appendix F of the FSAR rather than in the text as suggested in the draft "Guidance for Implementation of 10 CFR 50.34(g)."

PSI emphasized that the discussions of differences from the SRP criteria for replicate features will refer to the staff's acceptance of those features as discussed in the Byron SER. Examples of discussions of differences were shown for both replicate and nonreplicate items. The staff agreed that this format is acceptable for the Marble Hill SRP conformance review.

Finally, the staff agreed that the applicant's date for submittal of the SRP conformance review in April of 1983 is acceptable.
