This refers to the routine, safety inspection conducted by Mr. J. Linville of this office on September 1-30, 1982, at the J. A. FitzPatrick Nuclear Power Plant, Scriba, New York of activities authorized by NRC License No. DPR-59 and to the discussions of our findings held by Mr. Linville with yourself and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Our inspector also verified the steps you had taken to correct violations A brought to your attention in letters dated March 18, 1981, September 24, 1981, August 20, 1982, and violation C brought to your attention in a letter dated April 10, 1981. We have no further questions regarding your action at this time.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
