- 3. Your amendment request states that the changes you are requesting will not require changes to the Physical Security Plan. Please confirm that a sufficient amount of stored fuel will remain self protecting for the possession extention period to meet the requirements of your Physical Security Plan.
- 4. Your amendment request states that the criticality aspects of fuel storage at MURR are not changed by the request. Please provide a discussion of storage racks, k-effective, and stored fuel cooling for the maximum amount of fuel that will be in storage during the period of the proposed increased possession extention.
